

Bridal Services Contract

Thank you for choosing Premier Makeup Artistry for your bridal services. Please carefully review this contract. This contract must be completed and submitted with a 25% non-refundable deposit of the total expected cost of your services. The complete balance for your services will be due on the date of your event before application. Please feel free to contact me with any questions or concerns you may have in regards to your appointments. Thank you for your business!

Note: There is a minimum of four (4) people required for hair services and a minimum of four (4) people required for makeup service to book your date. Any and all add-ons and/or cancellations need to be made 30 days prior to the date of service. Any changes made less than 30 days prior to service are subject to availability and additional charges.

Description of Services

Makeup/Hair Consultation and Preview

This service includes a preview run makeup application and/or hairstyle for your wedding day. This session will take approximately 60 minutes for each makeup application and/or hairstyling and should be scheduled 2 months prior to the event date. Please feel free to bring photos, veil and hair pieces to share with your stylists and help guide them to how you vision yourself as a bride. Trials are typically held on Sundays, but we will schedule other days upon request.

Terms and Conditions

BOOKINGS: To secure a date, a signed contract is required with a 25% deposit due at the time of signing. The deposit is non-refundable and non-transferable. Please be advised, dates and scheduled makeup times will only be reserved when a signed contract and deposit are received.

DELAYS: A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if scheduled makeup exceeds allotted time because of client delays. Contract will state the times late fees will begin and the amount charged and will be initialed and approved by client.

TRAVEL FEE: A \$30 fee will be charged for locations inside of a forty (40) mile radius of the city of Joppa, MD 20185. For each additional 10 miles beyond this radius a \$10 fee will apply.

SERVICE LOCATION AND

REQUIREMENTS: Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the makeup artist needs to complete the makeup applications. A “set up” table/work area needs to be made available for the makeup artist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly.

CANCELLATION/MODIFICATION POLICY: You, the buyer, may cancel this transaction at any time prior to midnight of the third business day after the date of this transaction. After this date, cancellations must be made (30) days prior to your reserved date or you will be responsible for the amount of services agreed upon in this contract. Any contract modifications must be completed and approved (15) days prior to your reserved date.

PARKING FEES: Where parking, valet or toll fees may be incurred, the amount will be included with the final bill and due for payment on the date of your event before application.

SATISFACTION GUARANTEED: Makeup will be completed to client’s satisfaction, but is not to exceed allotted makeup time. Ample time is given for each makeup upon booking. Acceptance of completed makeup application by client is acknowledgement by client that makeup is done to his / her satisfaction.

LIABILITY: All brushes and makeup products are kept sanitary and are sanitized between every makeup application. Any skin condition should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist (Lindsey Drazba) from liability for any skin complications due to allergic reactions.

PAYMENT: The final balance is due on the date of your event before application – no exceptions. The person(s) responsible for the entire balance of payment is the person(s) who has signed the booking contract.

PHOTO RELEASE: The signing of this contract authorizes the makeup artist to use photographs taken before and after services rendered on their website, Facebook, Instagram, other social media pages, or any other advertising methods.
